## TO THE BOARD OF DIRECTORS OF Ravinder Heights Limited

- We have reviewed the accompanying Statement of Unaudited Consolidated Financial Results of Ravinder Heights Limited ("the Parent") and its subsidiaries (the parent and its subsidiaries together referred to as "the Group"), for the quarter ended September 30, 2025 and year to date results for the period from April 01, 2025 to September 30, 2025 ("the Statement") being submitted by the Parent pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended.
- 2. This Statement, which is the responsibility of the Parent's Management and approved by the Parent's Board of Directors, has been prepared in accordance with the recognition and measurement principles laid down in Indian Accounting Standard 34 "Interim Financial Reporting" ("Ind AS 34"), prescribed under Section 133 of the Companies Act, 2013, and other accounting principles generally accepted in India. Our responsibility is to express a conclusion on the Statement based on our review.
- 3. We conducted our review of the Statement in accordance with the Standard on Review Engagements (SRE) 2410 "Review of Interim Financial Information Performed by the Independent Auditor of the Entity", issued by the Institute of Chartered Accountants of India. A review of interim financial information consists of making inquiries, primarily of persons responsible for financial and accounting matters, and applying analytical and other review procedures. A review is substantially less in scope than an audit conducted in accordance with Standards on Auditing and consequently does not enable us to obtain assurance that we would become aware of all significant matters that might be identified in an audit. Accordingly, we do not express an audit opinion.

We also performed procedures in accordance with the circular issued by the SEBI under Regulation 33 (8) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended, to the extent applicable.

- 4. The Statement includes the results of the following entities:

    - v. Nirmala Organic Farms & Resorts Private Limited
- 5. Based on our review conducted and procedures performed as stated in paragraph 3 above and other auditor referred to in paragraph 6 & 7 below, nothing has come to our attention that causes us to



believe that the accompanying Statement, prepared in accordance with the recognition and measurement principles laid down in the aforesaid Indian Accounting Standard and other accounting principles generally accepted in India, has not disclosed the information required to be disclosed in terms of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended, including the manner in which it is to be disclosed, or that it contains any material misstatement.

6. We did not review the interim financial results of five subsidiaries included in the statement, whose interim financial results reflect total revenues of Rs. 5,500.11 Lakh & Rs. 5,512.04 Lakh, total net profit after tax of Rs. 4,004.25 Lakh & Rs. 3,970.34 Lakh and total comprehensive Income of Rs. 4,004.25 Lakh & Rs. 3,970.34 Lakh for the quarter/half year ended September 30, 2025 respectively and total assets of Rs. 39,783.94 Lakh & net cash Inflow of Rs. 253.65 Lakh for the half year ended September 30, 2025, as considered in the statement. These interim financial results have been reviewed by other auditors whose reports have been furnished to us by the Management and our conclusion on the Statement, in so far as it relates to the amounts and disclosures included in respect of this subsidiary, is based solely on the reports of the other auditor and the procedures performed by us as stated in paragraph 3 above.

Our conclusion on the Statement is not modified in respect of the above matter.

7. The statement includes the interim financial results of one subsidiary which have not been audited by their auditor, whose interim financial results reflect total revenue of Rs. Nil Lakh & Rs. Nil Lakh, total net loss after tax of Rs. 2.97 Lakh & Rs. 3.39 Lakh and total comprehensive loss of Rs. 2.97 Lakh & Rs. 3.39 Lakh for the quarter/half year ended September 30, 2025 respectively and total assets of Rs. 757.70 Lakh and total cash inflow of Rs. 26.81 Lakh for the half year ended September 30, 2025, as considered in the statement. These interim financial statements have not been reviewed by their auditor. According to the information and explanations given to us by the Management, this interim financial results are not material to the Group.

Our conclusion on the Statement is not modified in respect of the above matter.
